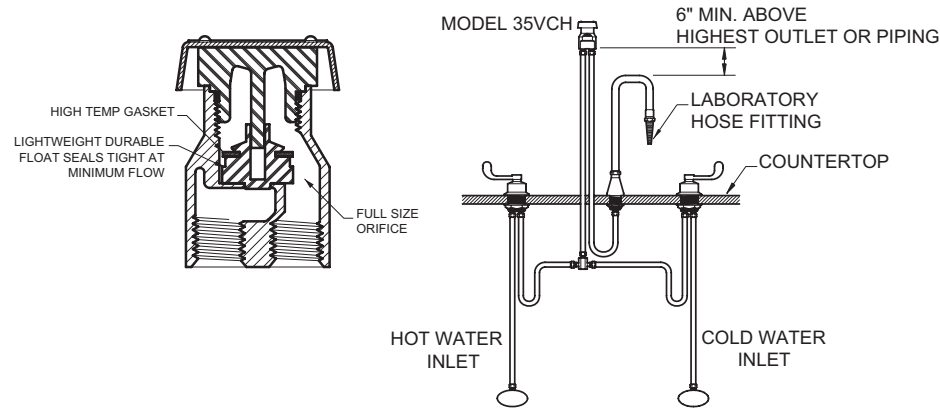
Atmospheric Vacuum Breaker (1/4")

Connect the supply piping to the bottom of the ZURN WILKINS Model 35VCH Atmospheric Vacuum Breaker. Connect the outlet of the Vacuum Breaker to the fixture being served as shown in the diagram below.

The extreme bottom of the AVB shall be taken as the critical installation level. Therefore, the highest fixture being served shall be a minimum of 6 inches below the bottom of the AVB.

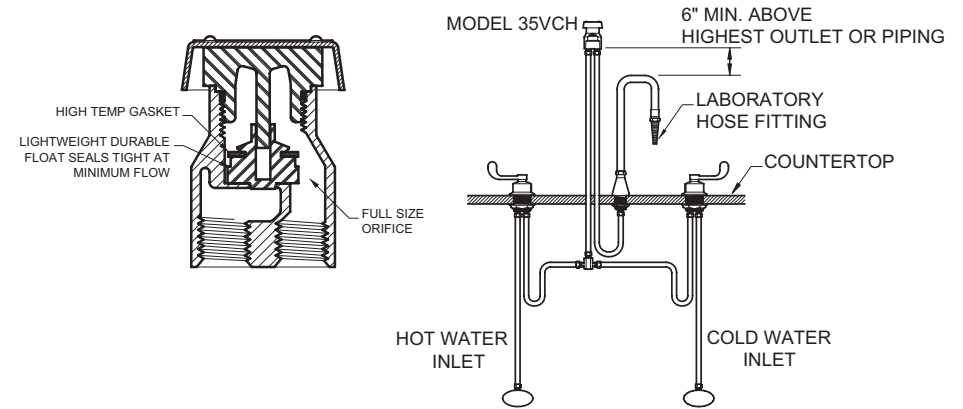
