





Typical Installation

Specifications

The Reduced Pressure Principle Backflow Preventer shall be ASSE 1013 approved, rated to 180°F and supplied with 90° union elbows and full port ball valves. The main body, access covers and elbows shall be bronze (ASTM B 584), the seat ring and all internal polymers shall be NSF® Listed Noryl[™] and the seat disc elastomers shall be silicone. The first and second check valves shall be accessible for maintenance without removing the relief valve or the entire device from the line. If installed indoors, the installation shall be supplied with an air gap adapter, and piped to a properly sized drain. The Reduced Pressure Principle Backflow Preventer shall be a ZURN WILKINS Model 975XLV.
