Fire Powerball Butterfly Valve

Application

Zurn Model F49BR / F49BRG Fire Powerball Butterfly sprinkler control valves provide for system shutoff to facilitate repair and maintenance. Fire Powerball Butterflies are operated with a slow closing 1/4 turn anti-water hammer valve. The valve should always be in the open position when the system is active. Tamper switches signal movement of the valve from the full open position to an alarm control panel, and to auxiliary equipment such as an indicating light or audible alarm in the area of the valve installation.

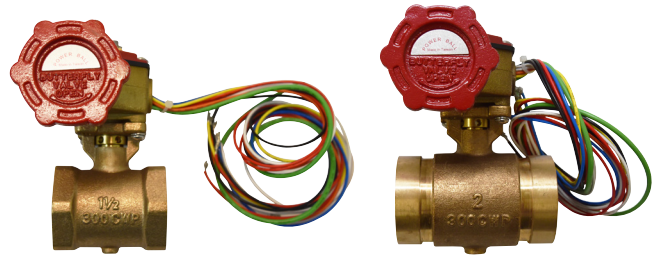

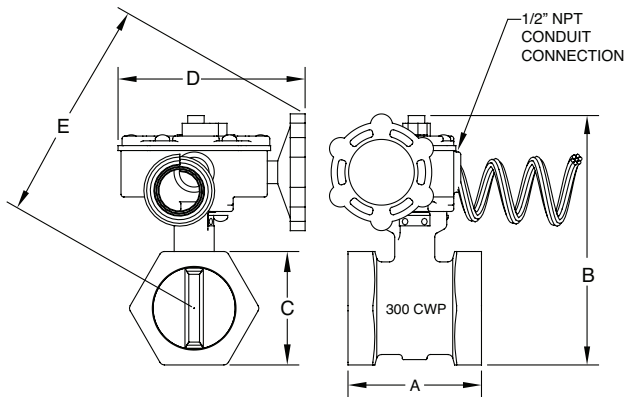

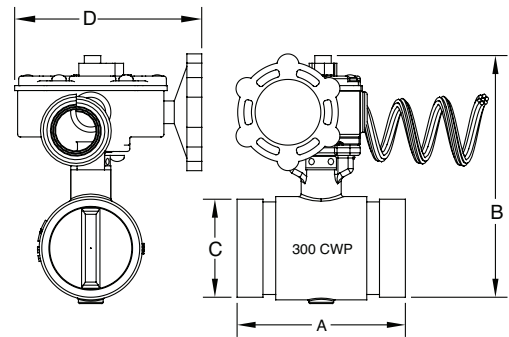

Wiring

Installation Instructions

1. Installation must comply with NFPA 13 and NFPA 7
2. The valve can be installed in any orientation in a piping system with standard ASME B1.20.1 NPT or standard roll or cut grooved pipe.
3. When threading to pipe, apply adequate pipe sealants, use a wrench to clamp on the hexagon end of the valve.
4. The valves are intended for use with ANSI B36.10 Schedule 40 and/or Schedule 80 pipe, sizes 1", 1-1/4", 1-1/2", 2", and 2-1/2".
5. All unused wires must be capped with wire nuts and placed in a junction box.
6. A No. 14 green wire is fixed inside the switch housing as a ground.
7. All connections need to be reviewed and approved by the authority having jurisdiction.

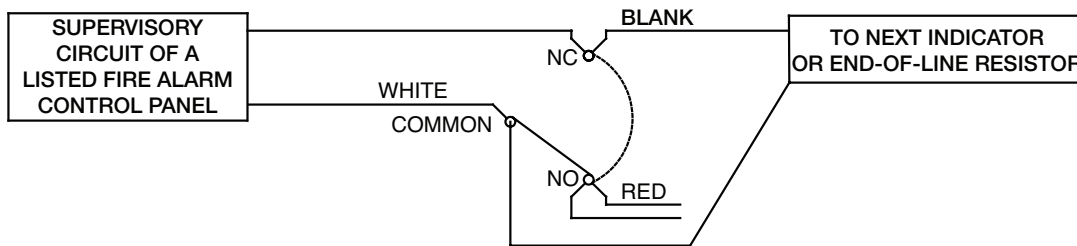
Wiring Instructions

The tamper has two switches: Switch 1 has dual leads on the terminals for connection to the supervisory circuit of a listed system alarm control panel. 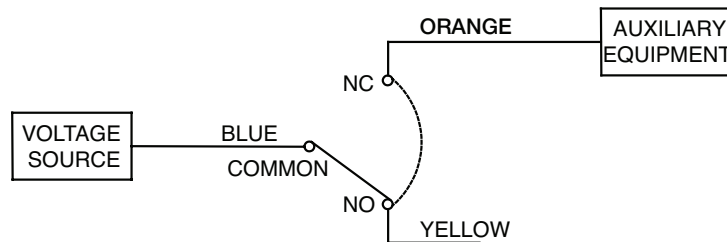
WIRING DIAGRAM

Green wire is provided as ground for the switch housing.
